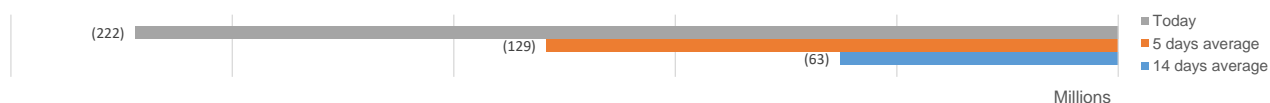
KMI 30 INDEX VOLUMES
